Paloma:

- -1.5 oz tequila
- -.5 oz of simple syrup
- -.5 oz of lime juice
- -.25 oz of Campari
- -1 oz of grapefruit juice

Build in a shaker with ice. Shake for about 20 seconds, strain into Collins glass, and garnish with a lime.

Irish Mule:

- -2 lime wedges squeezed
- -2 oz of Jameson
- -4 oz of ginger beer

Build in a mule glass with ice and stir after adding all ingredients. Garnish with a lime

5. New Business
